Description:

The site is brownfield land, formerly used for residential housing which consisted of a number of flats. The site lies in Brynithel, south of Abertillery town centre in a predominantly residential area on the periphery of Mount Pleasant Estate. To the south lies a playground and to the west open land. The site can be accessed from Mount Pleasant Estate, Brynithel.

Delivery Considerations:

There is a line of mature trees/dense scrub along the western and southern boundary, forming a wildlife corridor linking to adjacent broadleaved woodland these should be retained and considered in any future proposal. A survey of Japanese knotweed and programme for its eradication is required. The site is crossed by water mains which may restrict the density of the proposed development. Transport infrastructure improvements may be required to ensure developments are highly accessible.
