Application to vary Condition 3 (Approved Plans and Documents) and remove Condition 33 (Great Crested Newts) attached to Full Planning Permission ref: C/2021/0278 pursuant to Section 73 of the Town and Country Planning Act

LAND AT NORTH AND EAST RASSAU INDUSTRIAL ESTATE, RASSAU, EBBW VALE

Further to the above application made on 27 September 2023, the design team has made me aware of details relating to the roof plant and whilst they are minor features, I consider that these be shown on the planning drawings.

To capture this, please find enclosed updated plans in support of our recent submission of a Section 73 application (ref: C/2023/0209) in relation to the purpose-built glass bottle manufacturing factory at land at north and east Rassau Industrial Estate, Rassau, Ebbw Vale ('the site').

For the avoidance of doubt, the revised plans include details showing roof plant (air handling units), which were not shown on the plans submitted with the original Section 73 application on 27 September 2023.
